About the **Squamish Community Foundation**

Established in 2003, the Squamish Community Foundation (SCF) is an independent, charitable organization dedicated to enriching the quality of life for community members in Squamish. We facilitate philanthropy by partnering with donors and connecting them with community causes they value. As a Community Foundation, our focus is on building permanent endowments that address long-term community challenges as well as immediate needs. From the income earned on over \$1.9 million in endowment funds, we invest grants in people, groups, and community impact. With projects like Vital Signs & Annual Living Wage Reports, we are also working to build community knowledge, engagement, and leadership.



A Message from our Board Chair

2025 has been our busiest year yet! The SCF had a highly productive year as we continued to build our impact in the community.

As 2025 draws to a close, I am proud to reflect on another year of growth and collaboration at the Squamish Community Foundation. Entering the second year of our strategic plan, our focus remains clear: **Grow Our Brand, Grow Our Impact, and Grow Our Funds**—work that is only possible through the commitment of our board, partners, and community.

This year, our board and governance committee made meaningful progress on policy development, financial oversight, and advancing work that will allow us to expand granting opportunities in the future. Our granting committees were especially busy, awarding nearly \$43,000 through our annual grants to 13 community projects and 2 scholarships, and supporting 49 neighbourhood initiatives through the Neighbourhood Small Grants program.


We also continued to show up as a community leader—participating in the Squamish Living Wage process, hosting meaningful community events, and supporting local organizations through partnerships and sponsorships. These efforts reflect our belief that strong communities are built through connection, inclusion, and shared responsibility.

2025 Squamish Living Wage Report

The Squamish Community Foundation released our first ever Squamish Living Wage Report - a significant achievement.

The Squamish Community Foundation first partnered with the Canadian Centre for Policy Alternatives – BC Office and Living Wage BC to calculate the living wage for Squamish in 2023 then again in 2024 and 2025. The updated 2025 Squamish Living Wage Report was released in November. The SCF will continue to release the Living Wage Report annually.


The living wage is the hourly amount that each of two working parents with two young children must earn to meet basic expenses. In this calculation, basic expenses include rent, childcare, food, and transportation after government taxes, credits, deductions, and subsidies are taken into account; the living wage does not include debt repayment or savings.

As costs continue to rise, particularly for housing and food, Squamish’s living wage has been calculated at \$28.00 per hour for 2025; a 4.63% increase from the living wage of \$26.76 for 2024.

Food For Thought

Living Wage BC published **Food for Thought: Why is food so expensive in BC, and what can be done about it?** in August 2025. Funded by Vancouver Coastal Health, the report explores the root causes like climate change, supply chain disruptions, and corporate concentration in the grocery sector. These forces are making the food system more fragile and less fair. Though province-wide in scope, the report reflects Squamish perspectives collected through Kitchen Table Talks with local partners, including: Squamish Helping Hands Society, Squamish Senior Living Society, Squamish Climate Action Network, Howe Sound School District #48, Squamish Welcome Centre, and Sea to Sky Community Services. The Squamish Community Foundation helped bring local participants together for the Kitchen Table Talks, and Living Wage BC created sessions for seniors, people living with disabilities, migrant and low-wage workers, and new parents.

Annual Grants

\$42,900 in Endowment Fund distributions were shared with 13 organizations in 2025, including two scholarships totalling \$3,000 to students attending post-secondary institutions.

Funded by the income earned from our endowment funds, the Squamish Community Foundation awards Annual Grants to eligible organizations focused on causes that improve the lives and wellbeing of Squamish residents, including: Health and Social Development, Recreation and Sports Arts, Culture and Heritage, Children, Youth and Families, Environment, Music Education and Community Enhancement.

Neighbourhood Small Grants



This year, \$21,700 in grant funding was shared with 49 applicants interested in building community through the immensely popular Neighbourhood Small Grants program.

The Neighbourhood Small Grants (NSG) program is based on a simple, but powerful idea - that everyone is a valuable member of the community and that we all have something to share. Funded by the Vancouver Foundation and the District of Squamish since 2017, these grants have supported over 250 Squamish neighbourhood projects that nurture our community.

In 2025, we saw pizza parties, numerous block parties and community potluck events, BBQ's, a Friends Weekend, an Outdoor Community Library, Intergenerational cul-de-sac Community Garden, Bike Tours, Community Neighbour Halloween Parties and more.

In 2025 we administered \$107,185 in Community Enhancement Grants to 30 local organizations providing important services and activities to some of our most vulnerable community members.

The SCF has administered the Community Enhancement Grants (CEGs) for the District of Squamish since 2021. CEGs are geared towards projects that seek to enhance the community of Squamish through programming that aligns with the overarching goals of the District of Squamish’s Official Community Plan.

The Squamish Community Foundation hosted two community events this year, in alignment with our strategic priorities to Grow our Brand and Grow our Funds.


“Pride vs. Prejudice” Film Screening

In June, we had to postpone our community screening of *Pride vs Prejudice: The Delwin Vriend Story* due to the wildfire but was able to show it in October at the Brackendale Art Gallery.

The film tells the landmark Canadian story of Delwin Vriend, whose fight for equality reached the Supreme Court. Paired with a panel discussion, the evening highlighted both national history and the resilience of our local 2SLGBTQIA+ community.

The event was co-hosted with [Pride Squamish](#), [Sea2Sky Allies](#), and [PearlSpace](#). All proceeds supported Pride Squamish.

The evening had a great turnout - we sold 69 tickets - and the documentary was well received. We also had an engaging Panel discussion.



‘Squamish Gives 5%’ Campaign

On November 29, 2025 we held our Second Squamish Gives 5% Holiday Giving Campaign in partnership with several local businesses - Kaos Kids, Emily’s Hair Designs, Euphoria and Base Technology Ltd.
